

**MARSHALL COUNTY
BOARD OF COMMISSIONERS
MINUTES
JANUARY 2, 2018**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 8:30 a.m., Tuesday, January 2, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

REORGANIZATION OF THE BOARD OF COMMISSIONERS

Kurt Garner moved, second by Mike Delp, to retain Kevin Overmyer as President of the Marshall County Board of Commissioners for 2018. Motion carried 3-0.

Mike Delp moved, second by Kevin Overmyer, to retain Kurt Garner as Vice President of the Marshall County Board of Commissioners for 2018. Motion carried 3-0.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a road cut from NIPSCO on Union Road, between 5B Road and 6th Road, in Polk Township, at 5880 Union Road to remove Hole-Hawg drill stuck under the road. **Kurt Garner moved, second by Mike Delp, to approve the road cut for NIPSCO on Union Road between 5B Road and 6th Road, in Polk Township, to remove a Hole-Hawg drill stuck under the road. Motion carried 3-0.**

Mr. Peters presented Mailbox Regulations for County Residents to provide clarity to the Highway Department and Marshall County residents when a mailbox is damaged from either being hit by a plow or thrown snow stating that the County does not currently have a formal policy. Commissioner Garner stated that it may be appropriate to allow a stipend rather than provide a standard mailbox. Discussion was held concerning the mailbox set back. The Commissioners will take the matter under advisement and address it at an upcoming meeting.

Mr. Peters discussed residents placing steel posts as markers within a foot or two feet of the edge the road and the hazard it poses to vehicles and underground utility lines and suggested that fiberglass rods be used instead.

Commissioner Delp stated that there is a railroad iron placed at the corner of 7th Road and King Road and believes it to be a hazard and would like to see it removed or cut off.

Commissioner Garner requested that the directional arrow sign that was removed at the round-about following an accident on Christmas Eve day be replaced on the north side of the approach.

Mr. Peters explained that the road crews were out over the weekend and the roads are in good condition. They are expecting another load of Boost, which aids in clearing ice off the roads.

Mr. Peters stated that the Michiana Area Council of Governments (MACOG) Quarterly Tracking & Review meeting is scheduled for tomorrow, Wednesday, January 3rd at 9:00 a.m. and Call for Projects at the LaPorte District of INDOT on January 9th.

Commissioner Delp requested that the Commissioners continue to meet with the Highway Department for a monthly meeting to be held on the last Friday of the month.

ATTORNEY REPORT

Old Business:

Ricoh Copy Machine Contract: One of the master agreements has been revised as requested by Attorney Clevenger, but he has not seen the final draft. Attorney Clevenger spoke to both Ricoh Representative, Patrick Nau, and Councilperson Bill Githens, who asked to make redline revisions to the other maintenance agreement. Upon completion, the revisions will be submitted to the Ricoh legal team. Attorney Clevenger was advised that most of the proposed revisions were acceptable to Nau and he thinks they would also be acceptable to the Ricoh legal team. Mr. Nau is to provide Attorney Clevenger a copy of the paperwork verifying Ricoh as the winning vendor to the state governmental bidding process.

Neal Haeck: The Prosecutor and Mr. Haeck's attorney rescheduled an earlier hearing for January 4th at 11:00 a.m. Judge Bowen requested that Attorney Clevenger attend which he is planning to do.

Agreement with Plymouth for Planning Services: Attorney Clevenger sent a letter to Sean Surrisi, Plymouth City Attorney, advising that the proposed agreement needed to be modified if the County was going to approve it for the first three months of 2018. Mr. Surrisi has been on vacation and has not had the opportunity to deal with this matter.

New Business:

Attorney Contract: Attorney Clevenger submitted the Duties and Compensation Agreement between Marshall County Attorney and the Board of Commissioners of Marshall County for 2018, stating that it is identical to the 2017 Agreement. **Kurt Garner moved, second by Mike Delp, to approve the Duties and Compensation Agreement between the Marshall County Attorney and the Board of Commissioners of Marshall County for the calendar year 2018. Motion carried 3-0.**

Sheriff's Salary Contract: Attorney Clevenger submitted the Sheriff's Salary Contract for 2018 which is identical to the 2017 agreement, except the salary, which has increased to \$88,071.10. **Kurt Garner moved, second by Mike Delp, to approve the Sheriff's Salary Contract with the salary adjustment for 2018. Motion carried 3-0.**

Drainage Board: An attorney for the Indiana DNR called concerning a letter sent by Attorney Clevenger regarding the Lake of the Woods weir gate and the order concerning the lake water level. The DNR is concerned about appearing at a public meeting and discussing the situation since it is in litigation with the farm group led by Houin. The DNR attorney proposed a telephone conference instead with one or two board members to explain its position. A time will be arranged with Commissioner Garner and Surveyor Craig Cultice sometime the week of January 8th.

MINUTES
JANUARY 16, 2018**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioners Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 9:30 a.m., Tuesday, January 16, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Michael A. Delp, Member; County Attorney, James Clevenger; and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

ARGOS TOWN COUNCIL

Argos Town Clerk-Treasurer Lisa Mullaney, and Council member Suzanne Umbaugh, presented an Intergovernmental Agreement between Marshall County and the Town of Argos for Building and Planning Services, an annual agreement which includes services, advice and assistance through the County Building Commissioner. The Town agrees to pay the County an annual fee of three thousand dollars (\$3,000) for 2018 services as listed in the agreement with said sum paid on a quarterly basis to the County. Attorney Clevenger stated that he has reviewed the Agreement and it appears to be modeled after the agreement with the Town of Culver, with the exception of the Town of Culver paying two thousand dollars (\$2,000) annually, which is expected to increase to three thousand dollars (\$3,000) upon renewal. Ms. Mullaney thanked Chuck Dewitt and Ralph Booker for the assistance provided to date. **Mike Delp moved, second by Kurt Garner, to approve the Intergovernmental Agreement between Marshall County and the Town of Argos for Building and Planning Services in the sum of three thousand dollars (\$3,000). Motion carried 3-0.**

RICOH COPIER CONTRACT

Councilman Bill Githens and Ricoh representative, Patrick Nau, explained that Attorney Clevenger has been working with Ricoh on the copy machine contracts, Master Purchase-Lease Agreement and Service Agreement. Attorney Clevenger explained that Councilmember Githens, in an effort to save money, discovered that Ricoh received the State bid which Ricoh has confirmed. Attorney Clevenger stated that some of the requested revisions have been made. One requested change that did not occur was maintenance costs in some instances where the contract term exceeds twelve months can be increased up to 15% by Ricoh without notice to the County. The contract is ready for approval which sets up the framework and each purchase order complies with the Master Sales Agreement. Mr. Nau explained that Ricoh is in the third year of a four year State award and at the end of the term, Ricoh and the State can agree to extend the contract for two years. Mr. Nau clarified that the Master Lease Agreement and Service Agreement have fixed payments for a 60 month period and at the end of the term, the equipment may be purchased for one dollar (\$1). Community Corrections Director Ward Byers, requested clarification regarding the policy and procedure for department purchases and whether it was necessary to seek the Commissioners approval prior to entering into the Agreement. It was discussed that all department sub-agreements fall under the Master agreement and it is not necessary to seek prior approval; however, funding will need to be secured through Council prior to any agreements being executed.

Kurt Garner moved, second by Mike Delp, to approve the Ricoh Master Lease Agreement and Service Agreement and allow the President of the Commissioners to execute the agreement. Motion carried 3-0.

ELECTION BOARD

Clerk Deb VanDeMark presented the 2018 Infinity Voting System Annual Maintenance Agreement in the sum of \$12,000 which has not changed from years past. **Mike Delp moved, second by Kurt Garner, to approve the 2018 Infinity Voting System Annual Maintenance Agreement in the sum of \$12,000. Motion carried 3-0.**

GIBSON INSURANCE

Brian Kubicki, Representative of Gibson Insurance, presented the Insurance Services Agreement between Marshall County and Gibson Insurance, along with the Statement of Values. Mr. Kubicki stated that the total program cost has reduced by 6.4% from \$530,800 to \$498,060. Changes in Marshall County's exposures, including increases in payroll and property values, equate to an increase of just under 1%. Insurance company rates reduced by 6.77% overall with the majority of the rate decrease seen in the Workers Compensation policy. The workers compensation decrease is largely driven by two factors; decreasing rates in the State of Indiana overall and a reduction in the experience modification factor from 1.22 to 1.07 which reduced the overall rate for this policy by 14.23%, a reflection of the work done by the Safety Committee. Property exposure, driven primarily by building value, increased by 5.8% over last year. The property rate is down by 1.5%. Travelers did not require increases in building values, but Mr. Kubicki believes it has been more than five years since appraisals have been completed and suggests having appraisals completed for the County building and Highway Garage. Mr. Kubicki explained that there is a separate \$2,000,000 building limit for Shady Rest, with a \$25,000 deductible and stated that it is currently insured at actual cash valuation, not replacement value with coverage only being carried for no more than a six month period from January 31, 2018. If the Shady Rest location has not been sold, a separate policy will likely be required. The Gibson loss prevention fee has been reduced and Gibson would like to perform a risk assessment and prioritize items for further evaluation. County Attorney Clevenger asked if the County was covered for cyber security. Mr. Kubicki explained that the County does have some coverage, but a separate policy may be required and he will work with IT Director, Michael Marshall to evaluate cyber security coverage. **Kurt Garner moved, second by Mike Delp, to approve the Insurance Services Agreement and Statement of Values and to allow the President of the Commissioners to execute the documents. Motion carried 3-0.**

SHERIFF DEPARTMENT

Sheriff Matt Hassel requested permission for two employees to travel out-of-state to attend the National Interdiction Conference in Denver, Colorado, from April 29th through May 4th, which will help officers identify vehicle concealment areas. The costs will be paid by the Prosecutor and the Sheriff through a JAG grant secured by the Town of Bremen. **Mike Delp moved, second by Kurt Garner, to approve the out-state travel request for two employees to attend the National Interdiction conference from April 29th through May 4th in Denver, Colorado, with the costs incurred by the Sheriff and Prosecutor. Motion carried 3-0.**

TREASURER

Treasurer Angie Birchmeier explained that in previous years, the tax billing contract has been with Thomson Reuters in partnership with Worrell Corporation. Thomas Reuters has made a procedural change in transferring contract service liability and billing to Worrell Corporation. The partnership between Thomas Reuters and Worrell Corporation for data interface of the MVP property tax system remains intact. This change will have no effect in the terms and conditions of service to Marshall County. Ms. Birchmeier presented the renewal contract for 2018 stating that the estimated printing costs would be \$10,371.80 and estimated postage costs would be \$10,187.50 based on last year's tax file, representing a decrease in cost from last year. Ms. Birchmeier requested the Commissioners sign the Letter of Authorization allowing Worrell Corporation to prepare and mail the 2018 tax bills. Attorney Clevenger stated that he has reviewed the contract and brought a few minor changes to the Treasurer's attention. **Mike Delp moved, second by Kurt Garner, to approve the contract between Worrell Corp and Marshall County for the Worrell MVP Property Tax Bill Outsourcing Program 2018 Contract Renewal. Motion carried 3-0.**

HIGHWAY DEPARTMENT

Highway Supervisor Jason Peters presented the Agreement between Marshall County Board of Commissioners and Walsh & Kelly for resurfacing services performed on North Michigan Road (SR 931) from 1st Road to Tyler Road, approximately 1.4 miles, in the sum of \$325,250. Mr. Peters explained that this project was originally part of the Community Crossings Grant, but was not awarded. **Kurt Garner moved, second by Mike Delp, to approve the Agreement between Marshall County Board of Commissioners and Walsh & Kelly for resurfacing services performed on North Michigan Road in the sum of \$325,250. Motion carried 3-0.**

Mr. Peters presented three call for projects: Veterans Parkway Phase II, Bridge #87 - 11th Road over the Yellow River and Bridge #120 - South Upas Road over the Yellow River.

Mr. Peters requested an update on the mailbox replacement procedure, explaining that 30-50 mailboxes have been replaced and clarified that it is not the intent to have every mailbox in the County moved back off the road. Discussion was held and Mr. Peters was requested to research the mailbox policies of surrounding counties.

PLAN COMMISSION

Director Ralph Booker provided a PowerPoint presentation concerning 17-PC-23 Stockberger Trucking, a right-of-way request from Stockberger Trucking for a five lot subdivision located on parcels 50-32-10-000-007-000-018 and 50-32-10-000-013-000-018, at 11508 and 11652 11th Road, Plymouth, zoned R-2 Suburban Residential District. Mr. Booker explained that this was approved by the Plymouth Plan Commission on November 7, 2017. Further explaining that the right-of-way is to be dedicated to Marshall County and would require the Commissioners signature in order to be accepted. **Kurt Garner moved, second by Mike Delp, to accept the Stockberger Addition right-of-way dedication on 11th Road. Motion carried 3-0.**

HEALTH DEPARTMENT

Administrator Christine Stinson stated that she recently hired an Emergency Preparedness Coordinator who will start on January 22nd and is requesting permission for the new employee and Ms. Stinson to travel out-of-state in order to attend the Radiological Emergency Preparedness Post Plume Plan Review in Benton Harbor, Michigan, for a total of five days. The first course titled, AWR-317 Radiological Emergency Preparedness Concepts Course is February 6-7, 2018 and the second course titled, MGT-453REP Post-Plume Plan Review Course is March 20-22, 2018. These courses are for any emergency management program within fifty miles of a nuclear power plant and are designed to assist in developing a plan in response to a nuclear incident. **Kurt Garner moved, second by Mike Delp, to approve the out-of-state travel request on February 6th and 7th and March 20th – 22nd in Benton Harbor, Michigan to attend the Radiological Emergency Preparedness Post Plume Plan Review. Motion carried 3-0.**

ATTORNEY REPORT

Old Business

City of Plymouth Planning Services: Plymouth City Attorney, Sean Surrisi, revised the agreement as requested by the Commissioners at the December 18, 2017 meeting. If signed by the Commissioners it will be return to Mr. Surrisi for signature by the City of Plymouth.

New Business:

Amy Bacewic v. Sheriff & Quality Correction Care: Plaintiff filed suit, County received a tort claim notice in May 2017 alleged by the Plaintiff that she did not receive proper medical care at the jail. The lawsuit is brought under the ADA, claiming discrimination under the Act. Our insurance company adjuster has investigated the incident.

Two tort claim notices have been received regarding inmates at the jail which have been sent to Gibson Insurance and an adjuster has been assigned to begin the investigation.

AUDITOR REPORT

January 2, 2018 Minutes: Submitted for approval, Auditor Fox explained that the motion to appoint James Faulkner to the Culver Plan Commission should be omitted. Commissioner Delp stated that “Culvert Projects” at the top of page two should read “Call for Projects”.

Mike Delp moved, second by Kurt Garner, to approve the Commissioner Minutes of January 2, 2018 with the aforementioned corrections. Motion carried 3-0.

January mid-monthly claims: **Kurt Garner moved, second by Mike Delp, to approve the January mid-monthly claims as presented. Motion carried 3-0.**

Auditor Fox stated that the total revenues received as of December 31, 2017, for all funds, were \$90,301,101.62 and the total expenses were \$88,088,601.24.

COMMISSIONER ITEMS

Commissioner Garner stated that the Shady Rest Committee will be meeting February 1st at 2:00 p.m. in the Commissioners Room 203 of the County Building.

Commissioner Delp explained that Highway Supervisor, Jason Peters, has extended an Offer of Employment for the Highway Clerk. Further explaining that it is in the best interest to work together when hiring the Parts Manager and Assistant Clerk during the flux period.

Mike Delp moved, second by Kurt Garner, to allow Mike Delp and Jerry Ambrose to assist Jason Peters in the hiring process for the position of Parts Manager. Motion carried 2-1, with Kevin Overmyer voting no.

Mike Delp moved, second by Kurt Garner, to allow Mike Delp to assist Jason Peters in the selection of the Assistant Clerk. Motion carried 2-1, with Kevin Overmyer voting no.

Commissioner Delp suggested contacting Waggoner, Irwin & Scheele regarding an internal control hiring policy to assist Commissioner appointed department heads when hiring individuals. Discussion was held concerning adjusting the position descriptions to better define the position and hierarchy within the departments.

FEBRUARY 5, 2018**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 8:30 a.m., Monday, February 5, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, conducted a survey of adjacent counties concerning their mailbox ordinance and presented the findings for Commissioners review.

Mr. Peters stated that a culvert was replaced on 5th Road west of Plymouth-LaPorte Trail. Mr. Peters spoke with the salt supplier, who indicated that it may be possible to purchase additional salt, if needed, at the contracted price. Millings continue to be hauled in from the city and permission was requested to square off the fence to allow for a storage site. Mr. Peters received a verbal estimate for crushing asphalt at \$3.75 per ton and stone at \$4.50 per ton.

Commissioner Overmyer stated that when the Highway Department issues driveway permits it would be a good time to inform the property owner of the mailbox setback.

Commissioner Garner requested Mr. Peters provide an updated 2018 Road Plan for review at the next meeting.

DLZ

Laurie Johnson, P.E., presented a progress report of the Bridge 81 project since the last update on November 3, 2017: The current project letting date is February 7, 2018. As of last week, there are eight potential prime contractors on the plan holder list. The results will be monitored and the information communicated once it is received. DLZ was on-site last week to stake the right-of-way in preparation for clearing of the right-of-way and will work closely with Mr. Peters to be sure the trees are dropped in advance of the April 1st deadline. Once the project is awarded to the contractor, Marshall County will receive an invoice from INDOT for the required matching funds. To expedite the NTP, preparation to submit the funds to INDOT could be completed in advance of the award.

Ms. Johnson introduced Zach Dean, E1, DLZ Project Supervisor stating that he will be the day-to-day project supervisor working to ensure construction is in conformance with the plans and specifications.

COMMUNITY CORRECTIONS

Director Ward Byers explained that Kathleen Davidson submitted her resignation from the Community Corrections Board last month and is requesting that Daniel Franz be appointed to fulfill the unexpired term through 2019.

Kurt Garner moved, second by Mike Delp, to appoint Daniel Franz to the Community Corrections Board to fill the unexpired term of Kathleen Davidson through December 31, 2019. Motion carried 3-0.

OCRA GRANT

Shannon McLeod of Priority Project Resources provided an update on the OCRA Grant for the 4H Fair Board Multi-purpose Building and submitted documents for approval. The application request is for \$500,000 with a local match of \$300,000 for the construction of an 8,000 square foot metal building which will accommodate 400 plus people. In lieu of the annual allotment from the County, an upfront sum of \$215,000 will be provided upon letting of the construction bid in fiscal year 2019. Ms. McLeod explained that during the August 21, 2017 Commissioner meeting, the Commissioners approved the grant application on the condition that a Memorandum of Understanding between the County and 4H Fair Board be executed, which has not been completed due to the sub recipient agreement containing the MOU language. The initial public hearing was held on November 30, 2017 and the second public hearing will be held this evening in Commissioners Room 203 at 5:30 p.m. Ms. McLeod explained that minutes will be taken on behalf of the Commissioners. **Kurt Garner moved, second by Mike Delp, to approve Resolution 2018-02 Authorizing Application Submission and Local Match Commitment concerning the multi-purpose building to the Indiana Office of Community and Rural Affairs and allow the President to sign the necessary documents. Motion carried 3-0.**

Kurt Garner moved, second by Mike Delp, to rescind the requirement of executing the Memorandum of Understanding between Marshall County and the Marshall County 4H Fair Board in Resolution 2017-07 as approved on August 21, 2017. Motion carried 3-0.

Ms. McLeod stated that an entity can have three open OCRA grants and apply for a fourth provided that the projects are underway. Further stating that the survey is good for four years.

SHERIFF

Sheriff Matt Hassel requested permission to purchase four 2018 Ford AWD Utility Interceptors and authorize the President to sign the purchase agreement with Oliver Ford Lincoln. The quote is in compliance with I.C. 5-22-10 State Bid. The total price less trade-in values is \$103,996.

Mike Delp moved, second by Kurt Garner, to approve the state bid through Oliver Ford Lincoln of four 2018 Ford AWD Utility Interceptors at a total cost of \$103,996 with trade-ins. Motion carried 3-0.

Sheriff Hassel presented the 2017 DEA Equitable Sharing Agreement and Certification requesting approval to submit the report. Sheriff Hassel explained that the funding was used for law enforcement equipment, enforcement operations and investigations. **Mike Delp moved, second by Kurt Garner, to approve the 2017 DEA Equitable Sharing Agreement and Certification and allow the Sheriff to submit the report. Motion carried 3-0.**

TREASURER

Treasurer Angie Birchmeier, on behalf of the Treasurer, Auditor and Assessor requested permission to extend hours for tax collection as follows: Spring Tax Collection: Saturday, May 5, 2018 from 9:00 a.m. to noon; Wednesday, May 9, 2018 from 8:00 a.m. to 6:00 p.m.; and Thursday, May 10, 2018 from 8:00 a.m. to 6:00 p.m.

Fall Tax Collection: Friday, November 9, 2018 from 8:00 a.m. to 6:00 p.m.; Saturday, November 10, 2018 from 9:00 a.m. to noon; and Tuesday, November 13, 2018 from 8:00 a.m. to 6:00 p.m. **Kurt Garner moved, second by Mike Delp, to approve the spring and fall tax collection extended hours for the Treasurer, Auditor and Assessor. Motion carried 3-0.**

SHADY REST COMMITTEE REPORT

Commissioner Garner extended thanks to the Committee members and appreciated their participation in the process of accepting proposals. Four proposals were submitted, two were very similar and the Committee requested the two join together. Business plans and security concerns were discussed. A motion was made by the Shady Rest Committee to recommend the Commissioners proceed with allowing David's Courage to come into receivership of the Shady Rest property, passing 5-1, the one in opposition was not in favor of a lease. Commissioner Overmyer stated that he understands the need to help with the crisis and is in favor of supporting the project to make it successful further stating that we either help to stop the cycle now or pay later through courts, jail, probation, community corrections or coroner. Commissioner Overmyer suggested two entities appraise the Shady Rest Building, find a mid-point and sell the building, using the funds to build a new facility beside the Sheriff's Department. Commissioners Garner and Delp stated that they are in favor of moving ahead with the Shady Rest transfer as it would be handled similarly to the Bowen Center. Commissioner Garner stated that David's Courage may have an opportunity to obtain funding through an OCRA grant. County Attorney James Clevenger discussed items that would be recommended in the contract, explaining that there is also a sewer line running from the City of Plymouth and the County may want to include in the contract the option to extend. **Kurt Garner moved, second by Mike Delp, to deed the Shady Rest property to David's Courage, allow County Attorney Clevenger to work on contractual language and to implement a transitional oversight committee. Motion carried 3-0.**

BUILDING INSPECTOR

Director Chuck DeWitt presented the 2017 Year End Report stating that 815 building permits were completed and \$53,529,793 in valuation with between 200 and 250 open projects. Mr. DeWitt stated that the 15 Year Permit Comparison report (2003 to 2017) reflects an average of 452 permits per year. The contractor registration is steadily increasing with over 550 contractors registered.

TOWN OF CULVER

Jonathan Leist, Culver Town Manager, stated that the Intergovernmental Agreement between Marshall County and the Town of Culver for Building and Planning Services expired on January 31, 2018. Mr. Leist is requesting renewal of the Agreement with minor changes which include increasing the fee from \$2,000 to \$3,000 and adding a provision for automatic renewal. Mr. Leist explained that the fee paid to County is in addition to hours paid directly to Mr. DeWitt for services performed after hours. Mr. Leist explained that there was an oversight in payment of

the 2017 fee, which is forthcoming. **Mike Delp moved, second by Kurt Garner, to approve the Intergovernmental Agreement between Marshall County and the Town of Culver for Building and Planning Services in the annual sum of \$3,000 to be paid on a quarterly basis with automatic renewal.**

Motion carried 3-0.

ATTORNEY REPORT

Old Business:

Ricoh Copy Machine Contracts: The contracts have been completed on our part and are waiting on a return of copies signed by Ricoh.

Plymouth Planning Services Agreement: The agreement has been completed.

Amy Bacewic v. Sheriff and Quality Correctional Care: Attorney Steven Polick is representing the Sheriff and has represented the County before with satisfactory results. Mr. Polick advises that he has moved the case to federal court with the consent of counsel from Quality Correctional Care.

Harradon Tort Claim Notice: The claim was denied. The accident occurred on State Road 17 and not at an intersection.

Opioid Litigation: Our Indianapolis counsel filed suit in the Northern District Court. USA Today last week reported 250 counties, cities and towns have now joined the multi-district litigation.

New Business:

No new business to report.

ORDINANCE 2018-05

AMENDING THE PERSONNEL POLICIES HANDBOOK

Indiana Code 2-3-10, 34-28-7 was changed in April, 2017. It now states that employees of the jail may carry firearms and ammunition in the property as long as (1) they secure the firearm or ammunition, or both in a locked case, and (2) store the firearm or ammunition in the trunk or glove compartment or out of plain sight in the employee's locked vehicle. **Kurt Garner moved, second by Mike Delp, to approve Ordinance 2018-05 An Ordinance Amending the County of Marshall, Indiana Personnel Policies Handbook, 6.10 Security of Premises section and replacement of page 84 to follow State statute on first reading. Motion carried 3-0.**

Kurt Garner moved, second by Mike Delp, to suspend the rules and pass on second and third reading Ordinance 2018-05 An Ordinance Amending the County of Marshall, Indiana Personnel Policies Handbook, 6.10 Security of Premises section and replacement of page 84 to follow State statute on first reading. Motion carried 3-0.

Commissioner Garner stated that the Town of Bremen will be celebrating the 100 year birth of Governor Otis R. Bowen and would like to request a proclamation be handed down by the Board of Commissioners declaring February 26th as Doc Bowen Day.

Commissioner Delp requested guidance on book barristers located in the Court House.

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 9:30 a.m., Monday, February 19, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a right of way cut from QC Communications for Mediacom on 2A Road, between Old US Highway 31 and US Highway 6, in North Township for the installation of 2 – 1 ¼ inch Ducts and Coaxial Cable by directional boring at a minimum depth of 48" and install pedestal for service to 12798 2A Road. **Kurt Garner moved, second by Mike Delp, to approve the right of way cut from QC Communications for Mediacom on 2A Road, between Old US Highway 31 and US Highway 6, in North Township to install pedestal for service to 12798 2A Road. Motion carried 3-0.**

Mr. Peters stated that he has received notification from Indiana Department of Transportation regarding the Federal-aid Call for New Projects concerning Marshall County Veterans Parkway Phase II: Michigan Road to Pine Road and it was not selected to receive Federal Highway Administration funding at this time. However, the County has been awarded \$1,884,080 in Federal Highway Administration construction funds for the Marshall County Bridge #120: South Upas Road over Yellow River, DES #1702838. The funding may be used for up to 80% of the approved phases: \$0 Utility Construction, \$0 Railroad Construction, \$1,636,080 Construction, and \$248,000 Construction Inspection. The County was also awarded \$1,632,320 in Federal Highway Administration construction funds for Marshall County Bridge #87: 11th Road over Yellow River, DES #1702839. The funding may be used for up to 80% of the approved phases: \$0 Utility Construction, \$0 Railroad Construction, \$1,416,320 Construction, and \$216,000 Construction Inspection. Commissioner Garner stated that the amount awarded was impressive.

Mr. Peters provided a report for Community Crossings Potentials with traffic counts and mileage by Township, along with a listing of the main lines in the County planned to be chipped and sealed in the next two to three years.

Mr. Peters provided an estimate from USI for resurfacing the roads around Lake of the Woods as well as the main roads coming into the lake for a total construction estimate of \$1,608,495.25. Mr. Peters would like to consider paving the roads around Lake of the Woods in two or three phases as there are a significant amount of culverts. The project repairing the dam began in 2016 and has not yet been completed. Commissioner Delp questioned if the contract cost remains in place. Mr. Peters affirmed that the costs have not changed.

Mr. Peters presented a Revised 2018 Road Program for approval.

Mr. Peters provided a PowerPoint presentation displaying pictures of the road conditions from 2015, reiterating the cost and time involved to pave the roads. Mr. Peters further explained that crack and seal maintenance for all roads chipped and sealed is critical to prevent water damage.

Discussion was held concerning the removal of the four way stop signs placed at Linden Road and Veterans Parkway and establishing a consistent speed limit.

MUSEUM

Director Linda Rippy and Historical Society President Mike Miley provided a 2017 Historical Society Income and Expense Statement. Ms. Rippy explained that the Museum is currently being painted by a gentleman that needed to perform Community service. The exhibit honoring Doc Bowen's 100th birthday is on display, two grants for the sports room have been applied for through the Community Foundation and Eli Lilly Foundation. Mr. Miley encouraged the use of their meeting rooms, which can accommodate 75-80 individuals. Ms. Rippy stated that they had 2,985 volunteer hours and 9,751 visitors and they could not accomplish all that they do without volunteers and generally have more help than they can use, further stated that the staff does a wonderful job rotating the exhibits which assists in attracting visitors.

HEALTH DEPARTMENT

Administrator Christine Stinson provided a biography of Tracy A. Fox who has been nominated by the Marshall County Board of Health to fill the vacancy of Michele Riise as the Democratic Representative and requested the Commissioners approval for the term beginning February 19, 2018 and ending December 31, 2021. **Mike Delp moved, second by Kurt Garner, to appoint Tracy A. Fox to the Marshall County Health Board to fill the vacancy of Michele Riise, as the Democratic Representative for the term ending December 31, 2021. Motion carried 3-0.**

ERIC READ

Eric Read provided a PowerPoint presentation of pictures taken with his drone and explained the FAA registration requirements and regulations. Mr. Read is currently flying as a hobbyist, but is working on obtaining his license. Mr. Read explained that drone pictures may be used for inspecting waterways, roof repair, property management and future planning. Mr. Miley explained that traditionally drones are not covered under the liability policy and would recommend that a certificate of liability be obtained. Commissioner Overmyer suggested the use of drones for the Drainage Board.

ATTORNEY REPORT

Old Business:

Ricoh Copy Machine Contracts: The contracts have been completed on our part and are waiting on a return of copies signed by Ricoh. Council member Githens stated that he has not received the signed contract and they are still in process.

Culver Planning Services Agreement: Culver has approved the agreement.

Amy Bacewic v. Sheriff and Quality Correctional Care: A reservation of rights letter was received from our carrier which was expected given some of the allegations in the complaint.

Shady Rest: An agreement for the transfer of Shady Rest to David's Courage, Inc. has been drafted and sent to the Commissioners for review. A draft will be sent to David's Courage for its review before completion. **Kurt Garner moved, second by Mike Delp, to approve the Agreement between Marshall County and David's Courage, LLC with the modifications suggested by the County Attorney. Motion carried 3-0.**

Shady Rest Farm: Following up on the Highway Department request for additional acreage at the Highway Garage property, two acres will be cut out of the farm lease with MDRA Properties, LLC. A revised lease that is identical to the approved lease except for two acres less and a corresponding less amount. **Mike Delp moved, second by Kurt Garner to amend the Farm Lease between Marshall County and MDRA Properties, LLC from 163, to 161 with 44,366. Motion carried 3-0.**

4-H Fair Board/OCRA Grant Application (revisited): The certifications, resolution and sub-recipient agreement that were approved at the last meeting have been reviewed. A confidential memo has been sent to each Commissioner that included additional comments reviewing the County responsibilities. As indicated, the County is required to take a larger role as the applicant for this grant than some of the other grants in which the Commissioners simply act as a vehicle for the grants. OCRA grant money comes with a lot of "strings attached" and "red tape". Attorney Clevenger suggested that if the County is awarded the grant, that we look to additional security for our matching funds.

New Business:

Holl v Marshall County: The County and the City of Plymouth have been sued in Federal Court by a pro se Plaintiff. After reading the complaint, Attorney Clevenger does not know what either the City or County did wrong. There is no claim upon which relief can be granted. The only contract with the County was a Sheriff Deputy drove the Plaintiff to the Bowen Center in accordance with Judge Palmer's Order of Involuntary Commitment. GIE would like the County to agree that the same defense counsel represent both the City and the County in getting the complaint summarily dismissed. Attorney Clevenger recommended that the Commissioners consent. **Kurt Garner moved, second by Mike Delp, to approve the use of the same attorney as the City of the Plymouth to represent Marshall County. Motion carried 3-0.**

AUDITOR REPORT

February 5, 2018 minutes: Submitted for approval. **Mike Delp moved, second by Kurt Garner, to approve the Commissioner minutes of February 5, 2018. Motion carried 3-0.**

February mid-monthly claims: **Kurt Garner moved, second by Mike Delp, to approve the February mid-monthly claims as presented. Motion carried 3-0.**

COMMISSIONER ITEMS

Kurt Garner moved, second by Mike Delp to adopt A Proclamation Establishing February 26, 21018 as Honorable Doctor Otis R. Bowen Day in Marshall County. Whereas, the Board of Commissioners of Marshall County, Indiana do recognize the 100th anniversary

of the birthday of Otis Ray Bowen to be February 26, 2018; and, Whereas, the Board of Commissioners recognize the positive contributions “Doc” Bowen has made in Marshall County communities, our state and nation as a family physician, County Coroner, State Representative, Speaker of the Indiana House of Representatives, Governor, and Secretary of Health and Human Services to President Ronald Regan; and, Whereas, the Board of Commissioners seek to honor the work of this statesman, leader and friend by inviting all of Marshall County’s residents to reflect on the virtues of civic responsibility, community, and service to fellow man as demonstrated by the late Honorable Doctor Otis R. Bowen. Now, therefore, be it resolved, the Board of Commissioners of Marshall County, Indiana, proclaim February 26, 2018 to be “Doc Bowen Day” in Marshall County.
Motion carried 3-0.

Commissioner Garner explained that the City of Plymouth will be renaming Jefferson Street to Doc Bowen Avenue for the day on February 26, 2018.

Book Barrister: Culver Library requested several of the book barristers. Gary Masterson stated that there are several book barristers remaining. It was requested to have the Auditor send an email to the Schools, Towns and Libraries offering the book barristers.

Highway Department: Commissioner Delp suggested hiring part-time clerical to help in the office stating that there is a line for Seasonal Highway help.

Commissioner Delp stated that Mr. Bruce Breeden of Telamon Corporation, an energy assessment and management company, will come to the March 5th meeting to provide a presentation.

Commissioner Overmyer stated that as a Board a decision needs to be made at the Highway Department concerning filling the vacant positions of Assistant Clerk and Engineer/Director. Commissioner Overmyer stated that the Assistant Clerk position has always been filled and it was never stated that when the Highway Administrator was hired that the Assistant Clerk position would not be filled. Commissioner Overmyer stated that the Highway Clerk has almost 75 hours of compensatory time accumulated and the Highway Supervisor has worked 80 hours overtime. Commissioner Overmyer further stated that since no new resumes have been received for the Engineer position, he believes it is time to move on by hiring a financial administrator to oversee the clerical office staff and allow the Highway Supervisor to oversee the remaining Highway personnel. Since we are in the first year of the increased gas tax, it will be interesting to see where we are after receiving the financial payment from the State. Commissioner Overmyer further stated that he is still not in favor of an Engineer because of the revenue, but maybe things will change. However, we need to continue improving not only the Highway, but the County. Commissioner Overmyer would be open minded to a County engineer, appointed by the Commissioners, to work with the highway, surveyor and maintenance. The Engineer could act in a way that the Building Inspector has for the other towns and provide them an avenue for their projects with technical support. Commissioner Overmyer feels that Mr. Peters should be compensated for work he has done, either by adjusting the salary or moving him to an hourly rate. In summary, Commissioner Overmyer stated that we have to do something. Commissioner Delp stated that he needed clarification on the overtime hours for the Clerk.

Cumulative Bridge Fund: Commissioner Overmyer requested that the Auditor review the necessary steps needed to increase the Cum Bridge rate and timetable.

PUBLIC COMMENT

Council President Judy Stone, 124774 Muckshaw Road, Plymouth, Indiana, thanked Commissioners Delp and Garner for their presentation to Council last week. Ms. Stone explained that having been involved as the County Council MACOG representative and knowing the paperwork that is involved, she believes that an additional person needs to be added to handle the financials in the Highway Department and requests that the Commissioners provide a solid plan. Ms. Stone agreed that a County Engineer may be a viable option. Ms. Stone also stated that if we jeopardize our federal reporting, we also jeopardize our funding.

Mr. Leist explained that the property owner, Thomas Beste, has petitioned the town for voluntary annexation of the following parcels: 502117000032000013, 502117000039000013, 502117000044000013, 502117000016000013 and 502117000015000013. A public hearing has been scheduled by the Culver Town Council for Tuesday, March 13, 2018 to consider Ordinance 2018-002, an ordinance to annex Mr. Beste's property. **Mike Delp moved, second by Kurt Garner, to support the Town of Culver Ordinance 2018-002 annexing 71 acres of property into the Town of Culver's municipal limits. Motion carried 3-0.**

Mr. Leist presented the Intergovernmental Agreement between Marshall County and the Town of Culver for Building and Planning Services for the 2018 calendar year in the total sum of Three thousand dollars (\$3,000) to be paid on a quarterly basis for signature.

REES THEATRE PROJECT FUNDRAISER

Donna Pontius, on behalf of the Rees Theatre project fundraiser, explained that they are looking for unique items to auction during their October fundraiser and are requesting permission to auction one tour for four people of the Courthouse Clock Tower. **Kurt Garner moved, second by Mike Delp, to allow Rees Theatre project fundraiser to auction one tour for four people of the Courthouse Clock Tower upon providing additional information concerning the fundraiser. Motion carried 3-0.**

EMA

Director Clyde Avery explained that revisions to the Marshall County Comprehensive Emergency Management Plan are in order to more accurately reflect how the County will respond to emergencies and disasters. Mr. Avery presented the Quarterly Report from December 5, 2017 to March 4, 2018 stating that 25 NIXLE Alerts were sent out. Discussion was held concerning leaving the watch level in effect for travel restriction until further notice.

The Board of Marshall County Commissioners ratifies the following actions: February 20, 2018 a Disaster Emergency Declaration, in accordance with Marshall County Ordinance 2011-16, was implemented due to an immediate threat by a natural hazard, specifically significant flooding in German Township and a "Warning" Travel Advisory declared and remains in effect until terminated by the Board of Commissioners. Also on February 20, 2018 a Declaration of Emergency was implemented due to the immediate threat by a natural hazard, namely local flooding and historic flooding of the Yellow River to expire Monday, March 5, 2018 at 4:00 p.m. Marshall County officials asked individuals to use caution if and when they needed to be on the roads. On February 21, 2018 at 8:00 a.m. a Disaster Emergency Declaration was implemented due to an immediate threat by a natural disaster, specifically significant flooding in Marshall County including roads being washed out and water across roads making them impassable and a "Warning" Travel Advisory declared for all of Marshall County which remains in effect until terminated by the Board of Commissioners. On February 22, 2018 at 7:30 a.m. a Termination of Emergency Declaration was implemented and the "Warning Level" Travel Advisory Declared Emergency is hereby terminated for all of Marshall County. On March 5, 2018 the Marshall County officials declared an extension to the Declaration of Emergency issued on February 20, 2018 due to the excessive water accumulations creating hazardous driving conditions until Monday, March 19, 2018 at 4:00 p.m. in order to allow road crews to work on the roads. **Kurt Garner moved, second by Mike Delp, to ratify the Disaster Emergency Declarations implemented between February 20, 2018 and March 5, 2018. Motion carried 3-0.**

Mr. Avery is encouraging the public to report any damage incurred, to the Marshall County Emergency Management Agency (EMA). Federal funding will be based on an accumulated damage assessment for each individual county and the State as a whole. There is no federal financial assistance available at this point; data is still being collected for submission.

Mr. Avery requested permission to apply for the 2017 EMPG Salary Reimbursement Performance Grant through the Indiana Department of Homeland Security explaining that the federal grant reimburses the County for up to 50% of the EMA Director's salary and benefits for 2017. **Kurt Garner moved, second by Mike Delp, to approve the 2017 EMPG Salary Reimbursement Performance Grant through the Indiana Department of Homeland Security. Motion carried 3-0.**

Mr. Avery requested permission to attend a no cost Indiana Department Homeland Security (IDHS) Grants Management Workshop in Warsaw, Indiana on Tuesday, March 20, 2018. **Mike Delp moved, second by Kurt Garner, to allow Clyde Avery to attend the IDHS Grants Management Workshop in Warsaw, Indiana on March 20, 2018. Motion carried 3-0.**

Mr. Avery requested permission to attend a no cost Radiological Emergency Preparedness Radiation Meter and Field Sampling Training Class in South Bend, Indiana on Wednesday, March 21, 2018. **Kurt Garner moved, second by Mike Delp, to allow Clyde Avery to attend the Radiological Emergency Preparedness Radiation Meter and Field Sampling Training Class in South Bend, Indiana on March 21, 2018. Motion carried 3-0.**

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented several road cut permits from Century Link to install fiber optic cable. Mr. Peters explained that he and Surveyor Craig Cultice have reviewed the requests. **Kurt Garner moved, second by Mike Delp to approve the road cut permits for Century Link as presented today. Motion carried 3-0.**

Mr. Peters provided a road closure list due to high water, stating 98 roads were closed and several barriers were taken. Therefore, materials were placed in the roadway to prevent through travel. The Commissioners stated that additional supplies need to be purchased and tracking devices will be utilized going forward.

Commissioner Garner stated that this flood exceeded the 1954 flood by six inches. Mr. Peters explained that bids were requested for several culverts and bridges. Mr. Peters also provided a list of damaged roads. Since State Road 6 and State Road 331 were closed, county roads were damaged due to the additional traffic. Mr. Peters is in contact with the State and was encouraged that the State will assist in the repair of those roads.

Mr. Peters provided a statement of overtime hours for the Highway Department which does not include the overtime hours for snow removal.

Commissioner Garner stated that First Road blew up due to the rain and would like to consider the possibilities of restricting weight limit in order to preserve our main infrastructure roads.

Commissioners thanked the Highway Department for all their efforts during the disaster.

DLZ

Laurie Johnson, PE, provided a progress report of the Bridge 81 Project, Hickory Road Bridge stating the project was let on February 7, 2018. Five bids were received. After review of the bids, Grand River Construction, Inc. was awarded the contract for \$1,184,454.67. A notice to proceed with construction was issued to Grand River last week. A pre-construction meeting is scheduled for Friday, March 9th at 1:00 p.m. at the Marshall County Highway Department. Zach Dean's initial discussions with Grand River is that they will begin clearing of right-of-way activities on Monday, March 19th.

HEALTH DEPARTMENT

Administrator Christine Stinson requested approval for the reappointment of Thomas Pedavoli to the Marshall County Board of Health beginning January 1, 2018 and ending December 31, 2021. **Mike Delp moved, second by Kurt Garner, to reappoint Thomas Pedavoli to the Marshall County Health Board beginning January 1, 2018 and ending December 31, 2021. Motion carried 3-0.**

The Commissioners thanked Christine and staff for all efforts during the disaster. Ms. Stinson stated that over 100 individuals attended the tetanus shot clinic and they have an additional 100 shots available. Ms. Stinson stated that hygiene kits will be also be distributed. Well test kits will be available once supplies are received from the State. Ms. Stinson explained that wells can

and should be disinfected immediately and stresses the importance of inspecting the integrity of the wells.

BUILDING DEPARTMENT & PLAN COMMISSION

Building Commissioner Chuck DeWitt and Plan Commissioner Director Ralph Booker requested the Building Permit Fees be waived for a period of six months for flood victims. It is suggested that applicants come into the office rather than apply online in order to receive the waiver. Mr. Booker explained that there are FEMA requirements that will need to be met. **Mike Delp moved, second by Kurt Garner, to approve the six month waiver of Building Permit Fees for flood victims and application be made in-person in the office. Motion carried 3-0.**

Mr. DeWitt explained that he spent a good portion of last week with Clyde Avery, met many individuals and it was a good learning opportunity. Further stating that all of the departments worked well together.

SHERIFF

Sheriff Matt Hassel requested permission to send three employees to attend out-of-state training for Superion Customer Summit at Disney's Coronado Springs Resort in Orlando, Florida from June 4 to June 8, 2018. Sheriff Hassel explained that Superion is the vendor for OSSI software used by the jail, dispatch and CAD. **Kurt Garner moved, second by Mike Delp, to allow three employees to travel to Orlando, Florida June 4 to June 8, 2018 to attend Superion Customer Summit. Motion carried 3-0.**

Sheriff Hassel requested permission to apply for the Firehouse Subs Public Safety Foundation Grant. Sheriff Hassel explained that twenty-one ballistic vests for turnkey/dispatchers use during transports. The total cost of the grant is approximately \$17,000 and requires no matching funds. **Kurt Garner moved, second by Mike Delp, to approve the application for the Firehouse Subs Public Safety Foundation Grant to be used for the purchase of twenty-one ballistic vests. Motion carried 3-0.**

Commissioner Delp thanked Sheriff Hassel for the recent church training event.

ATTORNEY REPORT

Old Business:

Ricoh Copier: Attorney Clevenger stated that Ricoh has not returned the executed contract.

Amy Bacewic v. Sheriff and Quality Correction Care: The attorney representing the County has entered an appearance for the Sheriff and Captain and filed an answer, as well as motions to narrow the issues and probably dismiss some of the allegations that trigger no insurance coverage. A long litigation process has begun. Periodic updates will be issued.

David's Courage/Shady Rest: No response has been received from David's Courage concerning the proposed agreement transferring the Shady Rest Home.

Holl v Marshall County: Another reservation of rights letter from our insurance carrier on this federal court case will be forthcoming. As agreed GIE could be using the same counsel to

represent both the City of Plymouth and the County with a plan to have the case summarily dismissed.

New Business:

Flood Emergency Clean-up Services Agreement: Bill Dawson and Josh Walker provided clean-up services, including organization of volunteer assistance, through Heavy Equipment Response Coalition (HERC), a nonprofit disaster relief organization. HERC entered into a Disaster Response Agreement – Rev. 1 for Marshall County Flood Response with Marshall County and the City of Plymouth in the total sum of \$33,800. The City of Plymouth and Marshall County will share in the cost not to exceed \$16,900 each and requires approval of expenditures in excess of this approved budget amount. **Kurt Garner moved, second by Mike Delp to ratify the Agreement between Marshall County and Heavy Equipment Response Coalition (HERC) in an amount not to exceed \$16,900. Motion carried 3-0.**

Emergency Declaration: **Kurt Garner moved, second by Mike Delp, to allow Commissioner Overmyer the authority to sign an Extension of the Emergency Declaration if needed for an additional seven days. Motion carried 3-0.**

Cumulative Bridge Fund: The Auditor was asked to seek an increase in the tax rate for the cumulative bridge fund. The notice to taxpayers of a public hearing to reestablish the fund at the increased rate must be published two times, at least seven days apart, with the first publication being at least ten days before the public hearing and the second publication at least three days before the public hearing. Notice is to be published March 8th and March 15th. The public hearing is scheduled for March 19th. Taxpayers have the right to be heard. After the hearing, the Commissioners may vote to pass an ordinance adopting the proposed cumulative bridge fund and rate as presented, or a lower tax rate. If an ordinance is enacted, the Auditor must publish a notice of adoption. That notice begins a thirty day remonstrance period for the taxpayers. The Auditor, on behalf of the County, must submit the proposed new rate and all the necessary documents to the Department of Local Government Finance on or before April 30, 2018. This is on a very tight timeline with no room for delay if there is to be a new rate in 2019.

Auditor Fox stated that the proposed rate will not exceed \$0.0524 per \$100 of assessed valuation, which is \$26.20 per \$100,000 of assessed value. Commissioner Garner explained that USI provided a bridge survey and within five years the County would be at a \$2.2 million dollar deficit in 2023. There are currently two calls for projects and unknown costs associated with the flood damage. Commissioner Overmyer stated that each year the cumulative bridge decreases due to the tax caps and we are unsure of how much, if any, reimbursement will be received from FEMA. Commissioner Garner stated that we cannot have deficits to public safety.

Mike Delp moved, second by Kurt Garner, to approve having a public hearing on March 19, 2018 at 10:30 to raise the cumulative bridge fund to a rate of \$0.0524. Motion carried 3-0.

AUDITOR REPORT

February 19, 2018 minutes: Submitted for approval. **Mike Delp moved, second by Kurt Garner, to approve the Commissioner minutes of February 19, 2018. Motion carried 2-0-1, with Kevin Overmyer abstaining.**

March claims: **Kurt Garner moved, second by Mike Delp, to approve the March claims as presented. Motion carried 2-0-1 with Kevin Overmyer abstaining.**

COMMISSIONER ITEMS

Commissioner Delp stated that Bruce Breeding will be present at the March 19th meeting.

Commissioner Delp stated that a part-time clerical individual has been provided at the Highway Department.

Commissioner Overmyer thanked everyone for their efforts in a job well done.

PUBLIC COMMENT

Carol Anders inquired as to how all of the damages are going to be paid. Commissioner Garner explained that the individual needs to show a certain level of cost to the individual and all damages need to be reported in order to meet the FEMA threshold. However, we will not have a response from FEMA for a long time.

ADJOURNMENT

With no further business to come before the board **Kurt Garner moved, second by Mike Delp, to adjourn the meeting at 10:07 am. Motion carried 3-0.**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 9:30 a.m., Monday, March 19, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a road cut from Jones, Petrie and Rafinski for various partial lane road cuts along 5th Road for the installation of a sanitary sewer force main pipe along 5th Road for Swan Lake. **Kurt Garner moved, second by Mike Delp, to approve the road cut permit from Jones, Petrie and Rafinski for various partial lane road cuts along 5th Road for the installation of a sanitary sewer force main pipe along 5th Road. Motion carried 3-0.**

Mr. Peters requested permission for Attorney Clevenger to create a lease agreement between Marshall County and Wayne Houin, residing on Jarrah Road, for two acres of property to stockpile stone material on behalf of the Highway Department. Mr. Peters stated that two RFP's for Bridge #87 and Bridge #120 have been resubmitted for bidding and provided an update on Hickory Road Bridge. Further stating that a Preliminary Damage Assessment of Flooding has been provided to Clyde Avery, EMA Director. Mr. Peters stated that the flood response coalition was provided a fuel FOB for use by Mark Gidley, which will be billed to Heavy Equipment Response Coalition (HERC) at 121 W. Garro Street, Plymouth, Indiana for use during the flood recovery. Mr. Peters explained that the ditcher throws rocks into fields when used and every effort is being made to retrieve the rocks, further explaining that future consideration may be requested for investment in a rock bucket for the skid loader. Commissioner Garner requested the Highway Supervisor provide road miles damaged by PAR during construction of electric lines.

Michael Obergfell, PE, of USI Consultants stated that initial damages due to the flood are estimated at \$563,000 for the 20 bridges affected, however, the water level is still high and footings cannot be inspected. Mr. Obergfell stated that an assessment will be made once the water recedes and culverts over 20 feet will also be inspected.

Commissioner Garner asked Mr. Peters if there is a need for an emergency Council meeting to allocate funding for flood damage repair. Council President Stone stated that a meeting is scheduled on Monday, March 26th at 9:00 a.m.

TELAMON ENERGY CORPORATION

Dr. Bruce Breeden, Vice President of Energy Solutions for Telamon Energy Corporation, presented a brief overview of Telamon Energy Corporation stating that his focus is to assist and evaluate reduction of electric costs. The two main areas of concentration are solar operation and LED lighting conversion. A complete no charge analysis would be performed and the results would be available to the County. Dr. Breeden requested permission to perform an analysis of all the buildings. Discussion was held concerning the lighting updates at the jail. **Mike Delp moved, second by Kurt Garner, to allow Telamon Energy Corporation to perform an analysis of all County facilities except the Jail. Motion carried 3-0.**

DOSSETT CONSULTING

Jeff Dossett and Jeff Kemper with Dossett Consulting presented a brief overview of their background in County Government and Dossett Consulting. Mr. Dossett explained that their experience and background provide them with a complete and comprehensive knowledge of Federal and State laws concerning Cost Allocation Plans and Title IV-D Child Support Claiming Services. Mr. Dossett provided an estimate for services for future consideration. The Commissioners thanked Mr. Dossett and Mr. Kemper for the presentation.

SHERIFF

Sheriff Matt Hassel explained that when a Security Officer is off duty it leaves the County Building unattended. Sheriff Hassel presented a proposal to the Safety Committee to have officers and civilian employees who serve as reserve officers, to fill in for an off-duty Security Officer. Sheriff Hassel requested the Commissioners support in moving forward with the additional appropriation to Council in the total sum of \$15,000 for overtime wages to cover costs during security officer absences. **Mike Delp moved, second by Kurt Garner, to support the Sheriff pursuing an additional appropriation from Council for overtime wages during Security Officer absences in the total sum of \$15,000. Motion carried 3-0.**

ATTORNEY REPORT

Old Business:

David's Courage/Shady Rest: David's Courage, Inc., requested two revisions to the proposed contract for the transfer of Shady Rest: Remove the requirement that the facility continued to be named "Shady Rest", and remove the requirement concerning state residential care licensing. Also, the language has been amended to require David's Courage, Inc. to follow all state and federal regulations. **Kurt Garner moved, second by Mike Delp, to approve the contract between Marshall County and David's Courage, Inc. for the transfer of the Shady Rest home. Motion carried 3-0.**

Holl vs Marshall County: Attorney Lisa Brown, with the Betty Knight Firm in Merrillville, is entering her appearance on behalf of the County and the City of Plymouth. Ms. Brown has plans to try and dismiss many, if not all, of the allegations early on. Updates will be provided as warranted.

Cumulative Bridge Fund Rate Increase: The public hearing to increase the rate on this fund is scheduled for today. Taxpayers have the right to be heard. After the hearing, the Commissioners may vote to pass an ordinance adopting the proposed cumulative bridge fund and rate as presented, or a lower tax rate. If an ordinance is enacted, the Auditor must publish a notice of adoption. That notice begins a 30-day remonstrance period for the taxpayers. The Auditor, on behalf of the County, must submit the proposed new rate and all the necessary documents to the Department of Local Government Finance on or before April 30, 2018. Attorney Clevenger stated that this is on a very tight timeline with no room for delay if there is to be establishment of a new rate for 2019.

New Business:

Public Records Access Request: Since the last meeting, Attorney Clevenger has assisted with three requests for access to public records. The requests were made to three different departments and all were timely granted.

Courtside Ministries: Attorney Clevenger explained that a letter was received from a board member of the Christian Legal Society, a national non-denominational Christian membership association of lawyers, judges, law professors, law students, and other associates. Beginning on Monday, March 19th and to continue one morning each week outside the Marshall County Courthouse from 8:30 a.m. to noon, volunteers will serve individuals with a prayer table.

Executive Session: Scheduled for after today's meeting.

Motion carried 3-0.**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 8:30 a.m., Monday, April 2, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a revised 2018 Road Plan stating the current priority is working on the gravel roads damaged from the flood and repairing pot holes.

Mr. Peters stated that they met with FEMA last week and we have a few roads that qualify for federal highway funds and will be contacting FEMA again this week. FEMA estimated the road repair costs in the sum of \$636,259.21; bridge repair in the sum of \$298,000; and culvert repair in the sum of \$56,803.99 with a total estimated damage of \$911,063.20. The County does meet the FEMA threshold and are waiting to determine if the State meets the threshold. The reimbursement is based on the structures pre-existing condition and if awarded will be a 25% reimbursement. Mr. Peters provided a road progress update; the county-wide bridge inspections will be presented at the April mid-month meeting for approval. Mr. Peters is still waiting for a response from PAR NIPSCO regarding a scheduled meeting; quarterly tracking for King Road have been submitted to MACOG and we are in the process of wrapping up the annual report. Commissioner Overmyer requested Attorney Clevenger's assistance with PAR NIPSCO if necessary.

Commissioner Overmyer stated that he believes Mr. Peters salary should be increased to \$55,000 - \$57,000 per year due to the additional duties assigned and requested consideration for presentation to Council.

DLZ INDIANA, LLC

Zach Dean, Civil Engineer, provided a Bridge #81 Progress Update as follows: Grand River Construction (GRC) began tree removal Monday, March 26, 2018 and finished downing trees on Friday, March 30, 2018. GRC will continue to remove and clear the debris over the next three to four days. GRC has notified all schools and emergency responders of the closure date for Hickory Road, set for April 2, 2018. Bridge demolition will begin on Monday, April 2, 2018. Span C (North), Pier 3, and Bent 4 will be removed and constructed before continuing demolition of the remainder of the bridge. The project field office is located next to the County Highway Garage and was brought to the site on Thursday, March 29, 2018.

SHERIFF

Matt Pitney, Communication Supervisor, thanked the Commissioners for acknowledging the job the dispatchers do and the lives that are saved due to dispatching efforts and the service by Commissioner Overmyer on the Statewide 911 Board. Mr. Pitney explained that technology has drastically improved the ability to communicate and expressed his desire to have all full-time

dispatchers attend the Denise Amber Lee Foundation training and also training for the National Center for Missing and Exploited Children. Mr. Pitney further explained that dispatchers are experiencing the highest levels of Post-Traumatic Stress Disorder (PTSD) within the law enforcement profession. Mr. Pitney introduced Les Trump, a 21 year employee, and Ryan Schori, a 12 year employee, explaining that they are very active in the community, have an excellent ability to talk individuals through situations with empathy, are fine examples and wishes to recognize them for their work. Les Trump stated that they have an excellent group of employees and invited the Commissioners to come and listen to the dispatch calls. Mr. Pitney further explained that dispatcher Alex Truty volunteered to assist Clyde Avery with the flooding. Commissioner Overmyer stated that State wide the 911 Report indicates that Marshall County receives a lot of 911 emergency calls by text.

On behalf of the Commissioners, Commissioner Garner proclaimed National Public Safety Telecommunicators Week April 8th – April 14th, 2018. Whereas emergencies can occur at any time that require police, fire or emergency medical services; and, Whereas when an emergency occurs the prompt response of police officers, firefighters and emergency medical services is critical to the protection of life and preservation of property; and, Whereas the safety of our police officers, firefighters and emergency medical services is dependent upon the quality and accuracy of information obtained from citizens who telephone the Marshall County Central Dispatch Center; and, Whereas Public Safety Telecommunicators are the first and most critical contact our citizens have with emergency services; and, Whereas Public Safety Telecommunicators are the single vital link for our police officers, firefighters and emergency medical services by monitoring their activities by radio, providing them information and insuring their safety; and, Whereas Public Safety Telecommunicators of the Marshall County Central Dispatch have contributed substantially to the apprehension of criminals, suppression of fires and treatment of patients; and, Whereas each dispatcher has exhibited compassion, understanding and professionalism during the performance of their job in the past year; Therefore be it resolved that the County Commissioners of Marshall County declare the week of April 8th through 14th, 2018 to be National Public Safety Telecommunicators Week in Marshall County, in honor of the men and women whose diligence and professionalism keep our county, cities and citizens safe.

ATTORNEY REPORT

Old Business:

David's Courage/Shady Rest: Attorney Clevenger stated that he has not heard from the representative of David's Courage, Inc. concerning the completion of the revised contract for the transfer of the Shady Rest facility and trusts that Commissioner Garner is following up and will notify him if further assistance is needed.

Cumulative Bridge Fund: The public hearing to increase the rate on this fund was held at a previous meeting. The Auditor published a Notice of Adoption. That Notice began a 30-day remonstrance period for the taxpayers. The Auditor, on behalf of the County, must submit the proposed new rate and all the necessary documents to the Department of Local Government Finance on or before April 30, 2018. Please note the earlier deadline date.

New Business:

Rahul Palta Tort Claim Notice: Attorney Clevenger received an untimely tort claim notice from an attorney in Indianapolis on behalf of Mr. Palta. The tort claims an unreasonable excessive force in violation of the rights protected under 42 USC sec. 1983 by three deputies with the Sheriff's department. The same claim was made against the State and at least one Indiana State Trooper. The tort claim notice has been referred to Gibson Insurance and they will forward to GIE.

Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a road cut from Will Erwin Family Farms on 13th Trail, between State Road 331 and Beech Road, in Bourbon Township, for the purpose of installing drain tile. **Kurt Garner moved, second by Mike Delp, to approve the road cut permit from Will Erwin Family Farms on 13th Trail, between State Road 331 and Beech Road, in Bourbon Township, for the purpose of installing drain tile. Motion carried 3-0.**

Jason Peters, Highway Supervisor, presented four road cuts from Floyd Houin, the first road to be cut is Juniper Road, between 14th Road and 12B Road, in Center Township for the purpose of installing a culvert; the second road to be cut is Maple Road, between 13th Road and 14th Road, in Center Township for the purpose of installing a pipe; the third road to be cut is Juniper Road, between 14th road and 12B Road, in Center Township for the purpose of installing a pipe; and, the fourth road to be cut is Juniper Road, between 14th Road and 12B Road, in Center Township for the purpose of installing a culvert. **Kurt Garner moved, second by Mike Delp, to approve the four road cut permits from Floyd Houin as follows: Juniper Road, between 14th Road and 12B Road to install a culvert; Maple Road, between 13th Road and 14th Road, to install a pipe; Juniper Road, between 14th Road and 12B Road, to install a pipe; and, Juniper Road, between 14th Road and 12B Road, to install a culvert, all road cuts are in Center Township. Mr. Peters presented the LPA-Consulting Contract for County Bridge Inspections between Marshall County and USI Consultants, Inc. for the Marshall Countywide Bridge Inspection and Inventory Program in accordance with National Bridge Inspection Standards for Cycle Years 2018 through 2021, Phase I (2018), Phase IA (2019), Phase II (2020), Phase IIA (2021), DES 1592161. The maximum amount payable under this contract shall not exceed \$309,706.58. **Mike Delp moved, second by Kurt Garner, to approve the LPA-Consulting Contract for County Bridge Inspections between Marshall County and USI Consultants for the Marshall Countywide Bridge Inspection and Inventory Program for a four year term, from October 1, 2018 to September 30, 2022 in an amount not to exceed \$309,706.58. Motion carried 3-0.**

Mr. Peters presented a contract between Marshall County Highway and Wayne Houin for the purpose of leasing two acres per year at \$200 per acre for stone storage. Attorney Clevenger recommended a couple of changes be made to the contract. **Kurt Garner moved, second by Mike Delp, to approve the Agreement between Marshall County Highway Department and Wayne Houin with the changes as recommended by County Attorney for two acres. Motion carried 3-0.**

Mr. Peters stated that a meeting was held last week with PAR NIPSCO to assess damages and another meeting is scheduled for April 19th to come to an agreement regarding the damages.

Mr. Peters presented the Road Program 2018, revised after the flooding event of March 26, 2018, and Reclaimed Roads 2018 for approval. Mr. Peters requested consideration be made to receive bids for Kenilworth Road and Dogwood Road. Commissioner Delp questioned grinding Underwood Road south of the houses. Commissioner Garner expressed appreciation for the revised Road Plan and agreed with Commissioner Delp in contacting the residents on Underwood Road prior to grinding. Commissioner Delp asked if the Highway Department would be able to accomplish the work on the road plan or does it need to be subcontracted. Discussion was held regarding the funds allocated in the Rainy Day Fund and increased revenues of \$80,000 per month. Commissioner Delp expressed that the repairs need to be based on the condition of the road and the roads in German and Bourbon Townships are really bad. **Kurt Garner moved, second by Mike Delp, to approve the Revised 2018 Road Program along with the Reclaimed Roads 2018 on the condition that homeowners on Underwood Road will be contacted prior to grinding. Motion carried 3-0.**

Commissioner Garner expressed need for road signs when grinding the roads.

EMERGENCY MANAGEMENT AGENCY

Director Clyde Avery presented Resolution 2018-08 for Adoption of the Marshall County All-Hazard Mitigation Plan. **Mike Delp moved, second by Kurt Garner, to approve Resolution 2018-08 Adoption of the Marshall County All-Hazard Mitigation Plan. Motion carried 3-0.**

Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President and Mike Delp, member; County Attorney, James Clevenger and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Jason Peters, Highway Supervisor, presented a road cut from Marshall County REMC on 12B Road, between Elm Road and Fir Road, in Bourbon Township to bore electric line under the road for REMC electric upgrade at the west property line of 4647 12B Road. **Kurt Garner moved, second by Mike Delp, to approve the road cut from Marshall County REMC on 12B Road, between Elm Road and Fir Road, in Bourbon Township to bore electric line under the road for REMC electric upgrade at the west property line of 4647 12B Road. Motion carried 3-0.**

Mr. Peters presented a road cut from Glenn Woodward on Filbert Road, between 6th Road and 7th Road, in German Township, approximately 150 feet north of 6508 Filbert Road to install field tile. **Mike Delp moved, second by Kurt Garner, to approve the road cut from Glenn Woodward on Filbert Road, between 6th Road and 7th Road, in German Township approximately 150 feet north of 6508 Filbert Road to install field tile. Motion carried 3-0.**

Mr. Peters provided a progress report stating that all of the roads listed in the revised 2018 Road Plan have been reclaimed; they are in the process of spraying calcium; followed by the prime coat process; chip and seal should start in June. The Commissioners requested that the highway crew know and communicate the road plan when approached by the public. Mr. Peters provided a USI Consultants Progress Report from Brandon Arnold, PE, USI Project Manager for Bridge #73 – King Road over Yellow River (DES No. 1600931). Discussion was held concerning the meeting with NIPSCO and PAR last week regarding the damage to County roads and the repair costs. NIPSCO offered \$100,000 but the Commissioners did not think that was enough to cover the damages. Commissioner Delp stated that NIPSCO spent \$3 million on 100,000 ton of stone and the \$50,000 bond was not enough to cover the costs. Commissioner Overmyer stated that other counties were also collecting \$50,000 bonds because the project was initially only for an approach not building a road. A Proposal Agreement was presented between USI Consultants, Inc. and Marshall County for a Marshall County Road Asset Management Plan which is a Countywide Road Asset Management Plan in accordance with INDOT and LTAP requirements, in support of long term road planning, in an amount not to exceed \$10,000. Commissioner Garner explained that USI also does our bridge planning and the road plan will be based on data from MACOG, LTAP and Marshall County Highway Department including AADT, PASER Ratings, and different types of treatment costs factors. **Kurt Garner moved, second by Mike Delp, to authorize the President of the Board of Commissioners, after final review by the County Attorney, to endorse the Agreement between USI Consultants, Inc. and Marshall**

County for the Marshall County Road Asset Management Plan in an amount not to exceed \$10,000. Motion carried 3-0.

Aaron Schattl, 18969 Underwood Road, Culver, Indiana stated that he was initially concerned because he had not been contacted concerning the road work on Underwood Road and that a Highway road crew employee stated that Underwood Road was not on the list for repair. Mr. Schattl requested confirmation that Underwood Road was on the list of roads to be repaired. The Commissioners confirmed that Underwood Road would be repaired.

DLZ INDIANA, LLC

Zach Dean, Civil Engineer, and Laurie Johnson, PE, provided a Bridge #81 Progress Update as follows: Grand River Construction (GRC) finished removal of Spans B & C and Pier 3; Production piles for Pier 3 were completed on April 13, 2018; Due to weekend rain events April 14-15, the water levels flooded the cofferdam delaying the concrete pour for Pier 3 by three (3) days; Friday, April 20th a “water boil” was discovered adjacent to Pile #8 (east edge) of Pier 3. To equalize pressure, the cofferdam was flooded to river level. A geotechnical recommendation for repair was given on May 1, 2018. Mr. Peters stated that Hickory Road has been reclaimed to 2B, which may tie into the DLZ contract to pave the rest of the road and wanted to publicly thank Grand River Construction for the use of their pump to drain water and the City of Plymouth for allowing use of a 500’ hose.

COMMUNITY CORRECTIONS ADVISORY BOARD

Director Ward Byers explained that Sandy Rivers submitted her resignation from the Community Corrections Advisory Board as the victim advocate last month and is requesting that Sharon Dotta, be appointed to fulfill the unexpired term through December 31, 2019. **Mike Delp moved, second by Kurt Garner, to appoint Sharon Dotta to the Community Corrections Advisory Board to fill the unexpired term of Sandy Rivers through December 31, 2019. Motion carried 3-0.**

Mr. Byers stated that it is National Correctional Officers and Employees Week and wanted to publicly thank his staff and the Jail staff for their hard work.

COMMUNITY CORRECTIONS

The Honorable Judge Dean Colvin submitted a written request for permission to allow Christie Johnson of the Drug & Alcohol Program to travel to Lexington, Kentucky from May 14 – 17, 2018 to attend Prime for Life Certified Training and further requested permission for her to take a County leased vehicle assigned to Community Corrections. Director Ward Byers explained the need for the request in detail. **Kurt Garner moved, second by Mike Delp, to allow Christie Johnson to travel out of state to attend the Prime for Life Certified Training in Lexington, Kentucky from May 14 – 17, 2018 and to allow Ms. Johnson to take a County leased vehicle assigned to Community Corrections. Motion carried 3-0.**

EMERGENCY MANAGEMENT AGENCY

Director Clyde Avery was pleased to announce that Marshall County has been one of three counties awarded for flood damage and are eligible for both individual assistance and public assistance. Mr. Avery is looking for a location to hold public assistance briefing. Mr. Avery explained that it was a group effort to gather the numbers for submission. The Commissioners thanked Mr. Avery for his efforts during the flooding and period of recovery.

RECORDER

Recorder Marlene Mahler stated that the Recorder's Office has been e-filing for the past seven months and last month she, the Auditor, Assessor and staff members traveled to Howard County to view the DocRouter process and how it impacted each office, explaining that everyone in attendance was satisfied that it would work in Marshall County. Ms. Mahler presented the DocRouter contract to allow the electronic filing and transfer of documents between the offices, further explaining that there is no cost to the County and that IT Director Michael Marshall has confirmed that the software is compatible with our current system. Ms. Mahler explained that they would like to begin using the software June 1st but there are some behind the scenes items that need to be completed first. Commissioner Overmyer requested that this be calendared for next year to review the renewal. Auditor Fox expressed her gratitude toward the current Recorder, explaining that Ms. Mahler has put a lot of effort into project which will allow each office to immediately review the documents, explaining that documents may be processed within a day. Ms. Mahler stated that 18 percent of their documents are currently e-recorded. **Kurt Garner moved, second by Mike Delp, to enter into the EPN for DocRouter Software Agreement on behalf of the Recorder allowing the President Overmyer to sign the document. Motion carried 3-0.**

Ms. Mahler presented Bulk User Agreement, explaining that Black Knight has held the Bulk User Agreement for the past two years, the contract is due for renewal and she would like to enter into a new agreement with FIDLAR Technologies who will keep the discs and do the watermarks for three cents per copy. If the Bulk User Agreement is approved, then Ordinance 2018-07 would need to be enacted. In order to watermark our images, Ordinance 2018-08 would need to be enacted. In order to add the watermark, the County would need to purchase a watermarking program from FIDLAR Technologies. Auditor Fox explained that the Department of Local Government Finance will hold a hearing on the petition and provide notice to the first ten (10) taxpayers whose names appear on the petition. The public hearing has been scheduled for Wednesday, May 9, 2018 at 11:00 a.m. at the Marshall County Building, Commissioners Room 203. At this hearing, the DLGF will accept written and verbal testimony from interested persons. Following the hearing a determination will be rendered on the petition. IV-D Consulting Services: Marshall County has contracted with Maximus for years for consulting services related to support and administration of Federal and State programs and the recovery of funds due to the County. The current contract ends in 2018 and the proposed contract is for three years at \$5,200 per year or a total of \$15,600. Dossett Consulting was present a few meetings ago and the proposed contract terms are almost identical to Maximus except the fee per year is \$4,500 per year. Both contracts allow for a one (1) year term or a three (3) year term.

Motion carried 3-0.**

David's Courage: Mr. Erickson, on behalf of David's Courage, signed the Contract for the Transfer of Shady Rest. The Auditor has the original signed document.

4-H Fairgrounds Multi-Purpose Building: The County has been awarded an OCRA grant in the amount of \$500,000 to help construct a new community multi-purpose building on the fairgrounds. Attorney Clevenger has been working with the grant administrator and the 4-H Board. The County will own the building for at least seven (7) years the way this was set-up. We are working on revising the sub-recipient agreement and a lease between the 4-H Association and the County. There will be more information to follow.

New Business:

Marshall County Recorder: The Recorder has presented three (3) agreements and two (2) Ordinances, proposing related enhancements and updates in her services for her office. Attorney Clevenger has reviewed and discussed at length with the Recorder. Attorney Clevenger would prefer the agreements provide more protection to the County but the terms are typical for the type of contract proposed. The Recorder's remedy is termination. The Ordinances were drafted by the State Recorder Association and one was based on new legislation that went into effect March 15, 2018.

Council on Aging: Jackie Wright plans to attend the May 21st meeting with her annual request for the County to act as the pass-through governmental unit for her Federal Highway grants for transportation services provided through her agency.

Commissioner Overmyer stated that they have a similar situation with farmers planting crops to the edge of the road and the crops are also mowed. Commissioner Overmyer stated that the plants should be kept at a height of three feet. Mr. Eads stated that he could stay within the three-foot range.

Highway-County Bridge Inspection Contract: Attorney Clevenger reviewed the INDOT County Bridge Inspection Contract. The version is updated from the last contract but contains all of the typical provisions of this kind of contract when the INDOT funds are federal funds. Noting that the revised version includes additional language concerning compliance with the State's ethical rules by both County representatives and our consultant as an entity that has a business relationship with the State. County Forest and Mill Pond Forest: Attorney Clevenger is preparing an ordinance concerning prohibiting motorized vehicles in the two County owned forests.

A road program update was provided. Mr. Peters will attend the upcoming Council meeting to request an additional appropriation of \$300,000 in the Local Road & Street Fund. The bridge

inspections will begin in October and work will begin following review of the final report expected in November. Asset management was discussed, along with the October permit expiration for the culvert lining project at Lake of the Woods.

DLZ INDIANA, LLC

Zach Dean, E.I., provided an update on Bridge #81 Hickory Road: Grand River Construction (GRC) poured the bridge deck on 7/3/2018 and the concrete approach slabs on 7/13/2018; E&B Paving completed the HMA pavement on 7/19/2018; Traffic control specialists completed the striping on 8/1/2018; C-Tech started installation of bridge railing on 8/3/2018 and will complete the guardrail 8/6/2018. Project monuments will be installed today. Contract change orders for approval: (1) Time Extension Request: 3 days for river flooding May 31st – June 2nd; (2) Scope Change CO: Additional riprap to armor river banks at Pier 2 and 3 in the sum of \$7,682.33; (3) Time Extension Request: 5 days for river flooding, April 14th and 15th rain events; and, (4) Time Extension Request: 15 days due to water boil at Pier 3. Upcoming schedule: Hickory Road opened up to traffic on 08/07/2018; kick off meeting for mitigation site work is to be determined the beginning of September. Earliest date to begin work (Mitigation Site) 9/24/2018. **Mike Delp moved, second by Kurt Garner, to approve the four change orders, with additional costs to change order number two in the sum of \$7,682.33, with 80% reimbursed by the State of Indiana. Motion carried 3-0.**

BOYS & GIRLS CLUB OF MARSHALL COUNTY

Art Jacobs, President, along with Andy Purviance, Interim Executive Director, and Max Fischer stated that Billie Treber resigned and they are working with the National Boys & Girls Club for assistance in a complete evaluation of the program, including staffing, funding and community outreach. Mr. Purviance thanked the Board of Commissioners for their support explaining the purpose of Boys & Girls Club and how they help children make better choices, create teaching moments and developing character. Further stating that the Plymouth location is a state-of-the-art building and now affords them the opportunity to reach out to younger students. Their goal is to reach 200 children per day and are now at 150 children per day. The Bremen location is at the Bremen Community School which offers licensed math and language arts teachers focusing on kindergarten through third grade and will be expanding next summer to work with Pre-Kindergarten children. The Commissioners thanked the Boys & Girls Club for their efforts.

SHERIFF'S DEPARTMENT

Sheriff Matt Hassel requested approval for a pre-payment to Shade Master in the sum of \$15,670.60 for window security film for the County Building and Annex. Vermillion Security will be installing the automatic door locks in September. **Mike Delp moved, second by Kurt Garner, to approve the pre-payment to Shade Master in the sum of \$15,670.60 for the deposit for window security film for the County Building and Annex. Motion carried 3-0.**

Sheriff Hassel attended the Indiana Sheriff's Association roundtable meeting and provided a list of concerns and topics discussed, which are also concerns of the Marshall County Sheriff's Department: Daily per diem rate for housing an offender; Opioids and methamphetamine are the top two abused drugs; Statewide infrastructure to treat offenders with addiction and mental health issues; Body scanners are a must for all jails; and all Sheriff Departments are experiencing an increase in their jail population. Sheriff Hassel provided a Jail Population Average Daily Report from 2014 – 2017 and Monthly Average for 2018 explaining the reasons for the population increase: Pre-trial detainees that do not post bond; HB 1006 requiring all Level 6

felonies to serve their time in County jails; large increase in arrests for possession and/or dealing of methamphetamine; and the increase in the percentage of female inmates. It was discussed that the current jail was built ten years ago by RQAW and has a 239 bed capacity, adding an additional pod to the jail requires a feasibility study prior to construction. Sheriff Hassel explained a request to purchase a body scanner was placed in the 2019 budget, the State bid for a body scanner is \$135,000.

PLAN COMMISSION

Director Ty Adley requested permission to travel to Cincinnati, Ohio to attend the OKI Regional Conference for Planning, October 3 - 5, 2018, using a County vehicle. Mr. Adley stated that the Plan Commission has approved the travel request. **Kurt Garner moved, second by Mike Delp, to approve the out-of-state travel request by Ty Adley to attend the OKI Conference in Cincinnati, Ohio, October 3- 5, 2018 with use of County vehicle for conference travel. Motion carried 3-0.**

PROPERTY & CASUALTY RISK MANAGEMENT CONSULTING

Mike Miley presented a Risk Management Consultant proposal, stressing it is not to take the place of the insurance broker, but to work with the insurance broker to assist in identifying potential risk exposures in contracts. The Property and Casualty Insurance and Risk Management Agreement proposes a month-to-month service agreement in the sum of \$833. Mr. Miley recommended the contract begin October 1st as the insurance renews on January 31st. Attorney Clevenger reviewed the contract and suggested modifying paragraph four to add that Mr. Miley is not a county employee and add paragraph "L" to require Mr. Miley to present quarterly updates at the Commissioner Meetings. Mr. Miley stated that his non-compete agreement with Gibson Insurance ends in 2019.

ATTORNEY REPORT

Old Business:

Tax Sale 2017: A tax sale property buyer filed a petition to invalidate a tax sale purchase. A hearing was held on July 20, 2018. The Court ruled to dismiss the petition.

Holl v Marshall County: A new reservation letter has been received since the Plaintiff amended his complaint, but does not have a claim for relief. If the Plaintiff no longer seeks compensatory damages, GIE may withdraw its defense as our carrier is not required to provide defense for actions that do not seek covered damages. Attorney Clevenger believes that our counsel will seek another dismissal. It may succeed since one of the new requests made by the Plaintiff is to refer Federal Judge Simon for emergency detention.

Sheriff / Bacewic: Numerous plaintiff theories for relief were dismissed. The assessment is that our jail staff followed Quality Correctional Control direction, so there should be no Sheriff Staff liability.

New Business:

Transfer Real Estate to City of Plymouth: Resolution 2018-10: A Resolution of the Marshall County Board of Commissioners Authorizing the Transfer of Certain Real Property to the City of Plymouth. Explaining the unit will be placed in the initial intake room and only individuals being housed in the Marshall County Jail would be scanned. 2018 Tax Sale: Auditor Fox reported the 2018 Tax Sale Results: Certified properties of 146; 62 properties offered; 33 sold properties; and 29 unsold properties. The Master Services Agreement was presented for review and approval. **Kurt Garner moved, second by Mike Delp, to approve the SRI Master Services Agreement for the Year 2018. Motion carried 3-0.**

COMMISSIONER ITEMS

Telamon Corp.: Commissioner Delp explained that there are 2,911 bulbs that could be changed. If any bulbs have been replaced in the last ninety-days and meet the specification they may be applied for the rebate. Master Services Agreement and The Lighting Statement of Work No. 1 were presented with a total cost of \$73,502.57, estimated rebate of \$9,237 for a net cost of \$64,265.57 and an estimated annual savings of \$31,856.75. Discussion was held that funding is available this calendar year. Attorney Clevenger indicated that changes were made to the contract and Commissioner Overmyer will need to initial by those changes, if approved. **Kurt Garner moved, second by Mike Delp, to approve the Master Services Agreement between Marshall County and Telamon Enterprise Ventures, LLC with the Commissioner President to sign the contract. Motion carried 3-0.**

Culver Union Township Public Library Board of Trustees: Anton Zurbrugg submitted his resignation from the Board of Trustees of the Culver Union Township Public Library, effective October 1, 2018.

Safety Committee: Commissioner Delp reminded the Board that the courthouse will be closed tomorrow from 2:00 p.m. – 4:00 p.m. for Active Shooter Training and Stop the Bleed Presentation. Commissioner Delp explained that the Safety Committee will be reviewing the

tornado procedures for the County Building and Annex. An Amendment to the Marshall County Safety Procedures and Emergency Protective Measures will be presented at the next meeting.

Highway Department: Commissioner Garner explained that the Council removed the Highway Engineer/Director position from the 2019 Budget leaving a Supervisor role, but does not address Administration at the Highway Department. No job description describes the Administrative structure, leaving us with only half of the original structure. Council raised the Highway Supervisor's pay to reflect an Interim Superintendent's pay; however, the job description title does not align with the pay and needs to be cleaned up to reflect the structure. Commissioners will review the job description prior to the next meeting.

PUBLIC COMMENT

LAKE LATONKA

Michael Maddox, Vice President of the Lake Latonka Property Owners Association requested a list of concerns from Attorney Clevenger regarding the County work on private property of Lake Latonka. Mr. Maddox explained that the County has worked with the Association in the past, all materials and tree removal were paid by the Lake Latonka Association and have the funding in place for the current project. Attorney Clevenger explained the concern is that it is not County property and the Association is requesting a public entity to provide equipment and labor to a private entity. Mr. Maddox explained that they are willing to pay for equipment fees and labor costs and stated that he understands the Courts and the Boards concerns and does not believe they are in violation of the request as they are tax paying citizens.

Ed McDermott, Lake Latonka resident, questioned what would have to happen to allow the paving project. Attorney Clevenger indicated that the roads would have to be dedicated to the County and would no longer be a private road and the County would have to be willing to accept the dedication. Commissioner Garner explained that road repair funding is not based on property taxes, but is based on road mileage and the four miles in the Lake Latonka Association are not part of the Motor Vehicle Highway distribution as they are privately owned.

Discussion was held concerning guard rail replacement and the importance of obtaining an accident report for insurance claim purposes and the use of reflective material and LED lighting on road signs.

DLZ, LLC.

Zac Dean, E.I., provided a progress update on Bridge #81 Hickory Road: Grand River Construction (GRC) completed the remaining punch list items on September 20, 2018; Partial acceptance of Bridge #91 (Des. No. 1383474) was given to GRC on October 4, 2018, except for the NOT; Wetland Mitigation (Des. No. 1700389) grading began October 15, 2018 and finished on October 26, 2018; and Seeding of the mitigation area was completed on October 27, 2018.

Following is the upcoming schedule: Slusser's is waiting for mitigation site to dry out more before plantings can be done. They are aware of the contract completion date, November 16, 2018.

MUSEUM

Director Linda Rippy presented a Museum Report stating that there have been 9,600 visitors and event attendees as of September 30th; The Museum will be highlighted in *Serving up Christmas Time* magazine again; Evolution of Technology Exhibit placed in Plymouth High School; and funds have been raised to complete updates to the facility. Ms. Rippy recognized all of the volunteers for their hard work.

ATTORNEY REPORT

Old Business:

Jail Population: The inmate population at the jail remains high, but has dropped some according to Sheriff Hassel. It is doubtful that the reduction is due to the changes initiated by the Courts and Prosecutor just a few weeks ago. The jail population should continue to be monitored.

Telamon Contract: The contract was signed at the prior meeting.

Highway Department: Working on a draft ordinance for No Thru Trucks; A list of County roads that will be covered by the ordinance will need to be provided. Discussion was held to set the fine at \$100 for the first offense.

Joseph v Sheriff: This is a case pending in federal court since 2016. The Plaintiff claimed the arresting officer injured his hand during the arrest as he was being handcuffed. The incident was recorded on the officer's video camera. The video contradicted the Plaintiff's claims. There was no evidence of a hand injury at booking or during the Plaintiff's stay at the Marshall County Jail. The Judge recently granted a Motion for Summary Judgment in favor of the officer and the Department except for one count against the Department as to whether reasonable force was used when removing the Plaintiff from his vehicle. The Judge ruled this is a question of fact to be determined by the jury. The remaining count is not one based upon federal law, but the federal judge is retaining control of the case rather than sending it back to state courts.

New Business:

BIS Digital: The submitted paperwork is more of a work order than an agreement for the purchase and installation of new audio and video equipment. The concerns stated are the requirement to pay a 50% deposit before shipment and installation of equipment with the balance to be paid upon completion of installation; Only offers a 90-day warranty; A continuing yearly license fee of \$350 is required; and, the prior approval of the company and equipment by our I.T. Department, who should also be included in the training.

Contracts Reviewed: Jail phone system with Matt Pitney and Michael Marshall; Cash management accounts of TCU for the Treasurer and Various items for the Highway Department.

CHA

Summer Elmore, PWS Senior Environmental Scientist, CHA, provided a Project Status Report and Year Three Monitoring Report for 7th Road Extension Project, 7th Road Stream and Wetland Mitigation Site. CHA has completed the third year (of ten) of monitoring and invasive species

control for the wetland mitigation site for the 7th Road Extension project. The site is performing well, meeting all required permit success criteria except for tree survival. Unfortunately, tree survival is a common issue for mitigation site success and can be attributed to a variety of factors, including prolonged flooding, drought, predation by insects/animals, soil compaction, nutrient deficiency, timing of planting, storage, planting methodology, and plant competition. A supplemental planting should be conducted in spring 2019 to bring the site into compliance. It is proposed to have a subcontractor of CHA plant 390 trees for \$8,700 in the Spring of 2019.

DLZ INDIANA, LLC

Zach Dean, E.I., DLZ Indiana, LLC, provided a Progress Update on Bridge 81, since the last update on November 5, 2018: Slusser's completed plantings, tree protection, and mulching at the Mitigation Site on November 14, 2018; Meeting the Intermediate Completion Date (Milestone 3); Held a Pre-Final Inspection on Wednesday, November 28, 2018; Minor punch list items were noted; cut tree stumps, haul off logs still on site, and reset any fallen tree protection tubes. The upcoming schedule is as follows: Meet on site with Ryan Cassidy, US Army Corp of Engineers; Send Punch List (after meeting with USACE); Tree inspections – 75% of trees must survive two (2) growing seasons, the first around May 1, 2019 and second around September 15, 2019; Apply for N.O.T. (Notice of Termination) which requires 70% uniform vegetation growth, for both DES 138474 and DES 1700389.

EMA

Director Clyde Avery presented the EMA Director's Quarterly Report (September 17, 2018 – December 2, 2018) stating to date, FEMA has provided approximately \$350,000 in Individual Assistance directly to flood survivors in Marshall County. The Marshall County Long Term Recovery Committee is still very active and continues to provide support to flood survivors with unmet needs. There are still a number of open cases, including several residences that the construction team volunteers have been working to restore. Regarding the Public Assistance declaration, FEMA has agreed to reimburse the County \$13,177.15 for debris removal. They have not made a final determination regarding the reimbursements for other projects.

Mr. Avery requested permission to attend FEMA Individual Assistance and Public Assistance training on December 10-11, 2018 in Fulton County (no cost). **Mike Delp moved, second by Kurt Garner, to allow Clyde Avery attend the FEMA Individual Assistance and Public Assistance training in Fulton County on December 10–11, 2018. Motion carried 3-0.**

The Board of Commissioners of Marshall County, Indiana, met for a regular meeting in the Commissioner's Meeting Room 203, 112 W. Jefferson Street, Plymouth, Indiana at 9:30 a.m., Monday, December 17, 2018. Present were Commissioners, Kevin Overmyer, President; Kurt Garner, Vice President; Mike Delp, member; County Attorney, James Clevenger; and County Auditor, Julie A. Fox. The meeting was opened, the Pledge of Allegiance was given and the business at hand was heard.

HIGHWAY DEPARTMENT

Highway Supervisor Jason Peters presented Extra Work Authorization No. 1 from CHA for Project Number 31835, 7th Road/Marshall County Mitigation Site Monitoring, supplemental tree planting, which will be completed in early spring 2019 at a cost not to exceed \$8,700.

Kurt Garner moved, second by Mike Delp, to approve the Extra Work Authorization No. 1 between CHA Consulting, Inc. and Marshall County for Project Number 31835, 7th Road/Marshall County Mitigation Site Monitoring, supplemental tree planting at a cost not to exceed \$8,700. Motion carried 3-0.

Mr. Peters explained that the drug screen vendor, Midwest Toxicology Services, has moved to Texas from Indianapolis and twice when opening an email have obtained a computer virus from the Company; therefore, he is considering changing vendors. Mr. Peters further explained that they are not under contract and can terminate services at any time.

Mr. Peters provided the following Highway Department update: All of the 2019 bids have been received and reviewed; Information has been received regarding the second call for Community Crossings; and, The PAR material has been removed from Wayne Houin's property.

Mike Delp moved, second by Kurt Garner, to accept the Highway Department Bids with the exception of Hoosier Equipment, who did not submit a check, certified check or bid bond. Motion carried 3-0.

MIKE MILEY

Mike Miley stated that four proposals were received through Gibson Insurance to perform a full appraisal of County owned properties. Mr. Miley recommended two of the companies, American Appraisal and Industrial Appraisal Company. Four buildings located at the Highway Department were added and three memorial monuments including Chief Menomonee. An agreement with Industrial Appraisal Company was submitted in the sum of \$4,990 and includes the optional service to expand the scope of the assignment and include equipment utilizing the modeling approach in the sum of \$1,845 for a total cost of \$6,835, explaining that 60% of payment is due when the initial measurements have been completed and the balance is due upon completion of the report. Mr. Miley also recommended conducting an annual re-evaluation and maintenance service in the sum of \$300 per year, for three years. The last appraisal was completed in 2001. Attorney Clevenger will be provided a copy of the agreement for review and approval after the first of the year.

SHERIFF

Sheriff Matt Hassel and Communications Supervisor Matt Pitney explained that the jail telephone system main line has been down since December 7th with the initial problem being the power supply. Mr. Pitney has been working with IT Director Michael Marshall and County Attorney Clevenger on a new phone system with Indiana Electronics & Communications, which will be installed this week and is a one-year contract effective January 1, 2019 and the monthly cost of \$994 is lower than what is currently being paid to CenturyLink. Mr. Pitney explained that the system failure did not affect the 911 system. **Kurt Garner moved, second by Mike Delp, to approve the one-year contract with Indiana Electronics & Communications effective January 1, 2019 for providing telephone service at the Marshall County Jail. Motion carried 3-0.**

MARSHALL COUNTY BOARD OF HEALTH

Health Department Administrator Christine Stinson requested the reappointment of Craig Miller, M.D. to the Marshall County Board of Health for a four-year term effective January 1, 2019 through December 31, 2022. **Mike Delp moved, second by Kurt Garner, to reappoint Craig Miller, M.
