In accordance with Trial Rule 81 of the Indiana Court Rules, the Marshall Circuit and Superior Courts hereby give notice to the bar and the public that the Courts propose to amend or adopt the Local Rules as follows: LR50-TR05-MLR-01; LR50-TR03.1-MLR-02; LR50-TR07-MLR-03; LR50-TR16-MLR-04; LR50-TR26-MLR-05; LR50-TR53.5-LR-07; LR50-TR81 & AR1(E)-MLR-10; LR50-CR00-MLR-012; LR50-CR02.1-MLR-013; LR50-JR01-MLR-015; LR50-AR15-MLR-16; LR50-AR00-MLR-018; LR50-FL00-MLR-020; LR50-FL00-MLR-020; LR50-FL00-MLR-021; LR50-AR00-MLR-23; LR50-PR00-MLR-24 for the courts of record of Marshall County, effective January 1, 2026.

Supreme Court approval is required for Local Rules concerning special judge selection, reassignment of criminal cases, court reporters, and caseload allocation and will not take effect until approved by the Supreme Court.

Notice has been given to the public by posting on the website of the Marshall County Clerk and at the Indiana Judiciary webpage for Local Rules (<https://www.in.gov/courts/publications/local-rules/>), and by furnishing a copy to the officers of the Marshall County Bar Association. A paper copy of the proposed amended local rule(s) will be made available for viewing in the office of the Clerk of Marshall County, 211 W. Madison St. Suite 101, Plymouth, Indiana, during normal business hours.

The time period for the bar and the public to comment shall begin on June 1, 2025, and shall close on June 30, 2025. The proposed amendments to the rule will be adopted, modified or rejected before July 31, 2025, and, if required, the final version of the rule will be submitted to the Indiana Supreme Court for review and approval not later than August 1, 2025.




