October 13, 2010

WHEREAS, Marshall County, Indiana continues to be immediately threatened by a natural disaster- specifically county wide drought conditions, and:

WHEREAS, as of the 13th day of October, 2010 at 1200 hours we find that Marshall County is at an elevated risk of widespread fire hazard because of the ongoing drought conditions and;

WHEREAS, a County wide burn ban affecting certain activities is an appropriate public safety response to the fire hazards presented by the current drought conditions;

NOW THEREFORE, we, the Marshall County Board of Commissioners, declare, pursuant to the provisions of IC 10-14-3-29, that a state of emergency exists in the County and that we hereby invoke and declare those portions of the Indiana Code which are applicable to the conditions and have caused issuance of this declaration, to be in full force and effect in the County for the exercise of all necessary emergency authority for protection of the lives and property of the people of Marshall County.

We also declare that, effective immediately, the following activities are prohibited in Marshall County:

1. Open burning of any kind using conventional fuel such as wood, or other combustible material, with the exception of grills fueled by charcoal briquettes or propane (charcoal from permitted grill shall not be removed from the grills until the charcoal has been thoroughly extinguished);
2. The burning of debris, such as timber or vegetation, including leaf litter, and other such debris that results from building construction activities;
3. Campfires and other recreation fires, unless enclosed.

In addition, we strongly encourage our resident to refrain from using firework devices.

Reference is hereby made to all appropriate law statutes, ordinances and resolutions and particularly to section 10-14-3-29 of the Indiana Code.

All public offices and employees of Marshall County are hereby directed to exercise the utmost diligence in the discharge of duties required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives whether state or local.

All residents are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster service forces in executing emergency operations plans, and to obey and comply with the lawful directions of properly identified officers.

All operating forces will direct their communications and requests for assistance and operations to the Emergency Operations Center.

This Disaster Emergency Declaration shall be in effect until conditions improve.

WHEREAS, at of the 1st day of February, 2011 at 1300 hours we find that Marshall County is at risk for widespread drifting and near zero visibility conditions because of the blizzard conditions and;

WHEREAS, a County wide emergency declaration affecting travel and other activities is an appropriate public safety response to the current blizzard conditions that exist;

NOW THEREFORE, we, the Marshall County Board of Commissioners, declare, pursuant to the provisions of IC 10-14-3-29, that a state of emergency exists in the county and that we hereby invoke and declare those portions of the Indiana Code which are applicable to the conditions and have caused issuance of this declaration, to be in full force and effect in the County for the exercise of all necessary emergency authority for protection of lives and property of the people of Marshall County.

We also declare that, effective immediately, and in accordance with Marshall County Ordinance Number 2010-01, Marshall County is under a Level 2 Travel Advisory (Warning). A Level 2 Travel Advisory (Warning) means that;

1. Conditions are threatening to the safety of the public. Only essential travel is recommended (i.e. to and from work, emergency situations, etc). Emergency action plans have been, or should be, implemented by businesses, schools, government agencies and other organizations.

Reference is hereby made to all appropriate law statutes, ordinances and resolutions and particularly to section 10-14-3-29 of the Indiana Code.

All public offices and employees of Marshall County are hereby directed to exercise the utmost diligence in the discharge of duties required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives whether state or local.

All residents are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster service forces in executing emergency operations plans, and to obey and comply with the lawful direction of properly identified officers.

All operating forces will direct their communications and requests for assistance and operations to the Emergency Operations Center.

This Disaster Emergency Declaration shall be in effect until 0500 hours on Friday, February 4, 2011.


WHEREAS, Marshall County, Indiana was under a county wide burn ban due to drought conditions, and;

DISASTER EMERGENCY DECLARATION
MARSHALL COUNTY, INDIANA

WHEREAS, Marshall County, Indiana is immediately threatened by a natural disaster – specifically county wide blizzard conditions, and:

WHEREAS, as of the 4th day of February 2014 at 1900 hours (7:00p.m.), we find that Marshall County is at risk from a severe winter storm that will include, significant snowfall, and strong winds that will cause near-blizzard conditions with widespread drifting of roads, and near zero visibility;

WHEREAS, a County wide emergency declaration affecting travel and other activities is an appropriate public safety response to the severe winter storm conditions that exist or are expected;

NOW THEREFORE, we, the Marshall County Board of Commissioners, declare, pursuant to the provisions of IC 10-14-3-29, that a state of emergency exists in the county and that we hereby invoke and declare those portions of the Indiana Code which are applicable to the conditions and have caused issuance of this declaration, to be in full force and effect in the County for the exercise of all necessary emergency authority for protection of lives and property of the people of Marshall County.

We also declare that, effective at 1900 hrs. (7:00p.m.), and in accordance with Marshall County Ordinance Number 2011-16, those located in the unincorporated portions of Marshall County and the Town of Culver, are under a “Warning” Travel Advisory for a Declared Emergency;

1. No travel is permitted on Marshall County roads until the Order closing the roads has been terminated by the Board of Commissioners of the County , provided that the Order does not prohibit travel on county roads by individuals engaged in employment necessary to (1) maintain a safe rail system, (2) restore utility services, or (3) provide any other emergency public service; and
2. Emergency action plans have been, or should be, implemented by businesses, schools, government agencies and other organizations.

Reference is hereby made to all appropriate law statutes, ordinances and resolutions and particularly to section 10-14-3-29.5 of the Indiana Code.

All public offices and employees of Marshall County are hereby directed to exercise the utmost diligence in the discharge of duties required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives whether state or local.

All residents are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster service forces in executing emergency operations plans, and to obey and comply with the lawful direction of properly identified officers.

All operating forces will direct their communications and requests for assistance and operations to the Emergency Operations Center.
